The focus of the unit was human rights work but often other work would be carried out to protect the client's human rights and thus achieve the same or better result (for example unfair dismissal regarding discrimination in employment or other civil litigation or administrative law actions ending up in the SSAT or AAT).

A number of these actions were representative actions against large corporations or government departments and agencies, resulting in services such as Telstra supplying TTY machines and the State Department of Transport supplying accessible buses.

The Shean Inquiry - West Australian government set up an inquiry into the provision of education services to primary school children with varying levels of disability. The Inquiry took submissions to choose representative cases into each area of service provision. Elizabeth's submissions were chosen for all 3 areas and so she represented all of the children before the Inquiry.

One of the founding solicitors for the Legal Advice Service for People with Mental Illness Pilot Project, 1995. (This is a generalist legal service and advice did cover any area of law). Now a separately funded service under the auspices of the Health Department.
