# **PROFESSIONAL PROFILE**

## **Background:**

Nicholas Dillon was called to the bar of England and Wales in 1983 and admitted as a legal practitioner of the WA Supreme Court, the Federal Court and High Court of Australia in 1987. Nicholas was elected to the WA Bar Association in August 2001.

Before taking up practice as a barrister, Nicholas was a senior litigation partner of Corrs Chambers Westgarth and he has also been a company director including of a public listed company.

# General areas of experience:

Nicholas is experienced in providing senior corporate/commercial advice, crisis management and the conduct of and appearing as Counsel in major dispute resolution/litigation projects.

Nicholas has appeared before all WA courts, the Federal Court and High Court and in many other jurisdictions including the Administrative Appeals Tribunal, Royal Commissions, Warden's Court, Coroner's Court, Federal and WA Industrial Relations Commissions and numerous specialist tribunals. However, his main jurisdiction is the WA Supreme Court and specifically actions in that Court's Commercial and Managed Cases List.

Nicholas has also appeared for clients in numerous arbitration proceedings and has been an arbitrator in a number of commercial disputes.

## Areas for instructions:

Nicholas is available to accept instructions to act as Counsel to advise or appear in a broad range of civil and commercial matters. A number of specific practice areas are summarized below (in alphabetical order).

#### 1. Construction Law\*

Nicholas has acted in relation to a number of significant Construction Law disputes – including where the amount in dispute or damages exceeds \$100m. He is familiar with standard form construction contracts (AS contracts), alliancing agreements, private/public agreements and has drafted special project contracts. Over the last few years he has been engaged on a number of substantial mining infrastructure disputes. Nicholas has also acted in relation to delay claims.

#### 2. Contract/transaction/finance disputes

Nicholas has provided assistance in settling the terms of various transaction contracts and securities documentation. Nicholas has acted in relation to a number of substantial disputes arising from breach of contract and interpretation of contracts (including international business sale agreements, franchise agreements, government tenders, guarantees and security documentation).

#### 3. Corporations Law

#### 5. Insolvency\*

Nicholas has given advice in relation to corporate workouts, strategies for debt recovery, unfair preferences and insolvent trading. He acted for various parties in matters arising from the collapse of major institutions including Teachers Credit Society, Rothwells Bank, Bond Corporation and Westpoint.

#### 6. Insurance

Nicholas has acted in relation to a number of ship arrests/releases and ship casualties (MV Kirki, MV Jarrah, Aurora Australis and HMAS "Westralia"). Nicholas has settled shipping contracts, ship sale and charter party agreements.

#### 10. Property
