#### Overview

Dr Michael Douglas practises in commercial litigation and media law. He has specialist expertise in defamation, torts and the conflict of laws. He accepts briefs in all areas of law.

Prior to joining the bar, Michael was a Consultant at Bennett, where he regularly drafted submissions for matters in superior courts and worked on several high-profile matters.

Michael was previously a legal academic. His teaching and research included the conflict of laws, federal jurisdiction, procedure, media law, torts, property, and equity, among other subjects. His writing on the law has been cited by superior courts, including the High Court of Australia.

Michael's university studies were supported by full-ride academic scholarships, including a Fogarty Foundation Regional Scholarship. He attended Harvard Law School as a PhD exchange student. He has co-authored and co-edited 5 books, 2 of which are the leading text in their disciplines. They include the latest edition of *Nygh's Conflict of Laws in Australia*.

Michael was awarded the Chief Justice's Prize for the Best Performed Reader in the 2025 Bar Readers' Course.
